Restrictions

The State of Texas, County of Harris: Know all men by these presents: That I, Ben Taub, owner and holder of all of that certain real property situated in Houston, in Harris County, Texas, known and described as Vassar Place, an Addition to the City of Rouston, in Harris County, Texas, in accordance with the map and plat thereof which is recorded in Volume _ pere _ of the Records of Harris County, Texas, do hereby covenant, agree and declare that I, and every person who shall hereafter have or hold any lot in said addition, by, through or under me, shall have and hold the same subject to the following restrictions upon the use and occupancy (a) That said property shall be used for residential purposes only. thereof, to-with (b) That no part of said property shall be owned by or occupied by any person not of the Caucasian Race, seve and except that this restriction shall not be deemed to prohibit the occupancy by persons other than those of the Osucasian Race of servant quarters in connection with and appurtenant to premises actually occupied by persons of the Caucasian Rece, by whom the occupants of such servant quarters are actually employed. (c) That only one building for residential purposes shall be constructed on any lot in said addition, out this restriction shall not be deemed to prohibit the occupancy of servant quarters which may be constructed above or in conjunction with the garage outbuilding, provided that such quarters so constructed may be occupied only by the bons fide servants of persons occupying the main residence building on the premises. constructed above or in conjunction with the garage out-building shell under no circumstances be occupied until such time as the main residence building has been completed and is occupied. It is the purpose and intent of this paragraph, but without limiting the force thereof, to prohibit the use and occupancy of what is commonly known as a "garage-epartment." restrictions shall continue in full force and effect until December 31,1961, upon and after which date these restrictions shall become null, word and of no effect, but prior to which date these restrictions shall be deemed to be covenants running with the land, inuring to the benefit of any owner of any lot in said addition, and any owner of any lot in said addition shall be entitled by injunction or other appropriate proceedings, to prevent or abate the violation of said restrictions. Meither the execution of this instrument by me, nor the conveyance by me of any of the lots in said addition subject to these restrictions shall ever no deemed to impress any other property than the property hereinabove expressly referred to, with any restrictions whatsoever.
